### **Personal data that we process**

The Biblekiosk processes your personal data by using our services and / or by providing it to us yourself.

### **Below is an overview of the personal data we process:**

- First and last name
- Address (street, house number, postcode, town)
- Phone number
- Bank account number
- E-mail address

### **Special and / or sensitive personal data that we process**

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we can not check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. ### **For what purpose and on what basis we process personal data**

The Biblekiosk processes your personal data for the following purposes:

- Sending our newsletter
- Handling your gift
- You can call or e-mail if necessary to carry out our services

### **How long we store personal data**

The Biblekiosk does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. We always delete personal data within 7 years.

### **Sharing personal data with third parties**

The Biblekiosk never sells your information to third parties and only provides it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data in our assignment, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. The Biblekiosk remains responsible for these processing.

### **Cookies, or similar techniques, that we use**

The Biblekiosk uses technical and functional cookies, and analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember, for example, your preferences. We can also optimize our website with this. You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

The Biblekiosk analyzes your behavior on the website in order to improve the website and to tailor the range of products and services to your preferences.

### **View, modify or delete data**

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to data processing or to object to the processing of your personal data by The Biblekiosk and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in your computer file to you or another organization mentioned by you.
